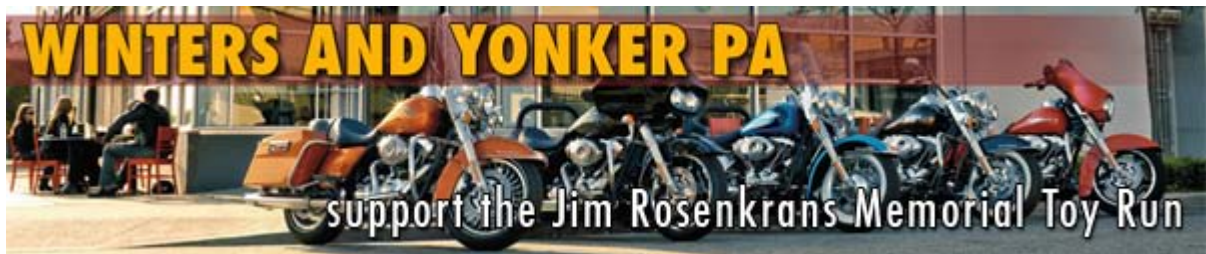

<p>Jamilou was a teacher at Rio Vista, Woodlawn and Skyview Elementary and experienced first-hand what obstacles the School System is up against.
